

- 5. In households where an animal is abused, there is often evidence of severe and on-going child, elder or spousal abuse.

THE "LINK":

Like rape, spousal/child or elder abuse, crimes against animals are an issue of power and control over a helpless victim. Because of this strong connection, police officers can benefit from learning more about investigating animal-cruelty and asking the right questions to identify other crimes.
